## Impact Raffle

## **Official Rules**

- 1. Online Early Bird Raffle Ticket sales for Project Infinity's Impact Prize Raffle will start at 12:00am on July 25, 2025 and end at 12:00am on August 1, 2025. In-person ticket sales will start at 6:00pm on August 1, 2025 and end at 7:30pm on August 1, 2025.
- 2. Must be eighteen (18) years or older, legal US resident at time of raffle entry purchase and must be present to win.
- 3. The number of eligible entries received determines the odds of winning.
- 4. Winners will be selected at random on August 1, 2025.
- 5. Winners must comply with all terms and conditions of these official rules, and winning is contingent upon fulfilling all requirements.
- 6. Prize(s) will be given to winners at the Impact Gala on August 1, 2025.
- 7. Winner is responsible for all taxes and fees associated with prize receipt and/or use.
- 8. In the event that a prize winner is not present, another prize winner will be drawn.
